Session 1 – chaired by Mr Khachatryan, SCWS

Pagistration of participants

Discussion, recommendations and decisions made under Session 1 of the Agenda:

- 1. Take into consideration the consultant's report on "NATIONAL POLICY DIALOGUE ON FINANCING STRATEGY FOR RURAL WATER SUPPLY AND SANITATION IN ARMENIA, Draft Final Report". The following changes are proposed:
 - ➤ The grant of KfW of € 3.9 mln should not be regarded as part of finance of the scenarios as this money is earmarked for management contracts (of which the expenditures are not included in the FS);
 - To consider that renovation and optimization of the current network may be more expensive than the mentioned AMD 27 billion in the report, due to additional expenditures needed for optimization;
 - To mention that "Nature" forms an important input in water supply (which will be further developed in the continuation of the work of the SC on Integrated Water Resources Management);
 - In the final report to add a section on potential costs of sanitation.

The SG meeting acknowledges that:

- 2. The Minimal Water Supply Standards are adopted by the SC and will be submitted to the relevant governmental body. Legal status will be decided within the further discussions;
- 3. For sound decision-making it will be needed to develop and maintain a database on rural WSS infrastructure and services in Armenia for which the Statistical Office will help to develop formats and implementation (as also needed for improved statistics);
- In the calculations presented in the draft final report the capital expenditures are included in the assessment of the potential needed water tariff increases (75% in MWSS, 100% in POLICY);
- 5. For the implementation of the financial strategy it should be considered to set up a WSS sector programmes/plan(s) implementation units. It is expedient to approach various donors which may wish to financially support establishing of such a unit.

The SG meeting:

- 7. Envisages a period until 31 March 2008 for submission of additional proposals and remarks concerning the draft final report;

Sessions 2 and 3 – chaired by Mr Narimanyan (new Chair)

Session 2: Transfer of responsibility from OECD to UNECE as strategic partner of Armenia on the NPD

According to the "Common Understanding on the National Policy Dialogue", the responsibilities for the dialogue process have been transferred from the State Committee of Water System (Ministry of Territorial Administration) with OECD as strategic partner to the Water Resources Management Agency (Ministry of Nature Protection) with UNECE as strategic partner.

Respectively, Mr Narimanyan, Deputy Head of the Water Resources Management Agency, has become new Chair of the Steering Group to be established to guide, and provide a platform for the NPD on IWRM issues, while Mr. Yura Pepanyan will be nominated as a Member of the new Steering Group.

- 1. The Minister of Nature Protection has invited other ministries and agencies as well as competent NGOs to become members of the new Steering Group.
- 2. The meeting of the newly established Steering Group on IWRM issues was tentatively scheduled to take place on 29-30 May 2008 in Yerevan. The agenda for the meeting will be finalized by mid-April.
